FreedomCare versus ObamaCare

It would safeguard individuals with pre-existing conditions from being discriminated against when purchasing health insurance by bolstering state-based high risk pools and extending HIPAA guaranteed availability protections. HIPAA is the Health Insurance Portability and Accountability Act of 1996. Insurance will continue to play a role in a free society, and it can be kept affordable by letting insurance companies compete on a nationwide basis and come up with innovative plans to fit each person's needs.

These Republican FreedomCare measures will work, but they're not the complete solution. That will come from all of us changing our thinking and our expectations when it comes to health care. If we had done it sooner, then ObamaCare wouldn't have been foisted on us. Hopefully, ObamaCare will be the wake-up call that gets all of us thinking of and demanding better ways of doing things.
